ARTICLE 1 DETAILS OF PHOTO SHOOT

Photographs are made of the model that shaves (or trims) the beard, where the upper part of the body is not covered with clothes. The model comes to the shoot in an unshaven state. The shoot lasts three hours and takes place in the city of **BREDA** (The Netherlands) on **[day] [date]** at **[time]**.

ARTICLE 2 PURPOSE OF PHOTO SHOOT

The photographs are intended for publication on shareyourshave.com (scherendeheren.net). This website is not commercial: it is an intermediary that pursues to generate money for a charitable organization as mentioned on the website. Donors pay their donation directly to this charitable organization.

ARTICLE 3 COMPENSATION

The model agrees that he receives no financial compensation nor travel allowance for the modelling work. It is a TFP assignment (Time For Print/Portfolio): the model receives his images digitally, within four weeks after the photo shoot.

ARTICLE 4 PERMISSION

The model gives explicit permission to publish his photographs on shareyourshave.com and its redirects and for publication related to promotion of shareyourshave.com, both printed and digitally. The model will not claim his personal image rights. The model may only use the photographs on a noncommercial base, for instance on social media or as part of his own model portfolio, both printed and digitally, provided that '© scherendeheren.net' or '© shareyourshave.com' is mentioned. The model may not edit and/or sell the photographs. For use or abuse of the images by third parties, neither the model nor the photographer nor the initiator or the website (and redirects to) scherendeheren.net is liable.

ARTICLE 5 IDENTIFICATION

At request of the initiator, the model will identify himself with a valid ID: a valid passport (or ID card) or drivers license.

ARTICLE 6 PRIVACY

Both initiator and model are not allowed to provide (personal) information to third parties without mutual consultation. The model gives permission to include his data in the records of the website and to use this data for communication in relation to the website.

ARTICLE 7 DISPUTES

This agreement is governed by Dutch law. Any disputes arising under this agreement will be resolved by mutual consultation. If this results in an undesirable situation, the disputes will be submitted to the jurisdiction of the court in the city of Breda (The Netherlands).

ARTICLE 8 SIGNATURE

By signing this document, both the initiator and the model declare to have fully read and understood this agreement and agree unconditionally with its full content. The model also declares to have been sufficiently and well informed of the nature, content and purpose of the photo shoot.
